## Terms & conditions:-

- 1. Training partner shall complete the assigned work before 31st Jan, 2022 positively.
- 2. The Training Partners should mobilise trainees in consultation with PRIs & Executive Engineer cum Member Secretary, DWSM, Kangra covering preferably nearby 10 Gram Panchayats for each batch.
- 3. List of Trainees mobilized /selected should be got approved from Executive Engineer cum Member Secretary, DWSM, Kangra.
- 4. The mobilized persons should have first hand relevant experience in the sector to be trained

- 5. Training Infrastructure shall be provided by skilling agency as per norms.
- 6. Batch size should be 30-40 person/batch.
- 7. Training should be provided in compliances to JJM guidelines available at <a href="https://jalshaktiddws.gov.in/sites/default/files/JJM Operational Guidelines.pdf">https://jalshaktiddws.gov.in/sites/default/files/JJM Operational Guidelines.pdf</a> and GoI/State Govt. instructions/SOP regarding COVID-19 should be adhered to strictly.
- 8. Before commencing the training detail of propose certified trainer and training schedule should be shared in advance with Executive Engineer cum Member Secretary, DWSM, Kangra.
- 9. The trainers must be certified from Sector Skill Council or should have experience as a trainer in ITI of the State.
- 10. Wide media coverage of the programme should be made.
- 11. Formal inaugural/closing session should be organized and Local Public Representatives be invited for the same, as far as possible.
- 12. The agency shall submit work plan within 7 days to Executive Engineer cum Member Secretary, DWSM, Kangra under intimation to the office of the Chief Engineer cum Director (SWSM), Jal Shakti Bhawan Shimla-5.
- 13. Payment shall be made by Executive Engineer cum Member Secretary, DWSM, Kangra on production of bills and list of qualified trainees after successful training programme.
- 14. Duration of training shall be 6 days (8 hr/day) with sixth day for final assessment. Rs. 4039/20 (Rupees four thousand thirty nine and twenty paisa only) per qualified candidate shall be payable.
- 15. No training partner shall be allowed to withdraw midway during the training program. In case of default, agency shall be liable for strict action including blacklisting for future programmes.
- 16. In case the Agency does not perform as per approved work plan or in case of performance being unsatisfactory, the department reserves the right to cancel the order without prior notice on the recommendation of concerned Executive Engineer cum Member Secretary, DWSM.
